Unit is furnished with a 2.2 GPM [8.3 L] pressure compensating aerator (complying with ANSI A112.18.1 Standard for flow), vandal-resistant color-coded metal four arm handles, mounting hardware and 1/2" NPSM coupling nuts for standard lavatory risers. 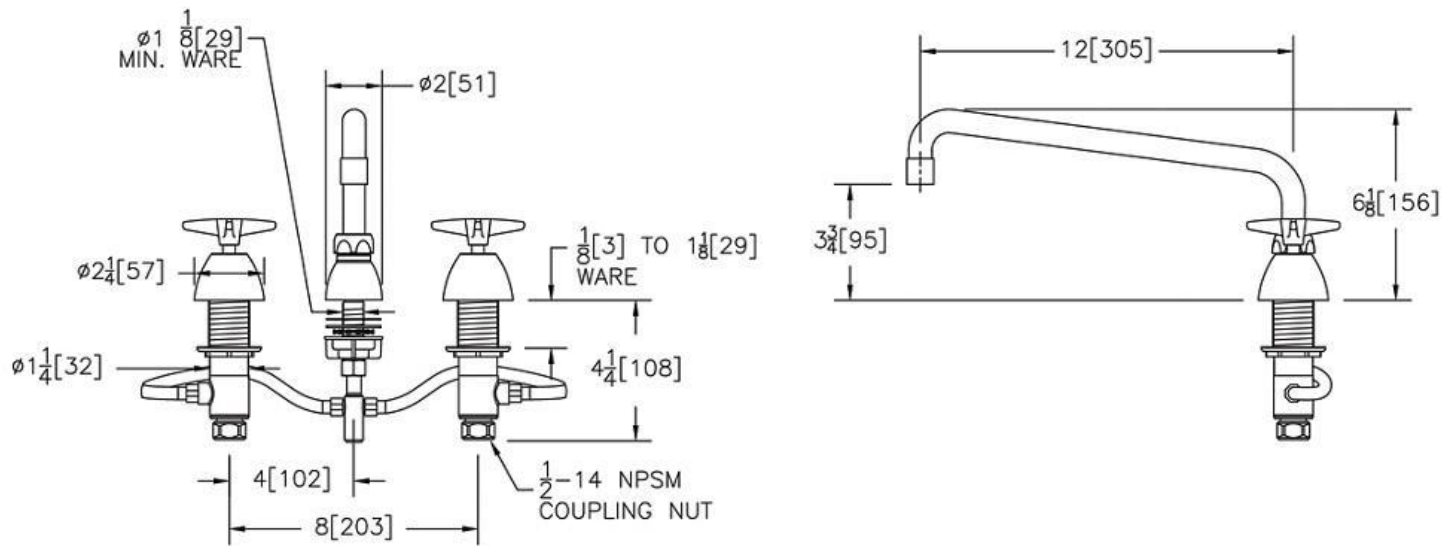
